We may share data only with:

- **Service Providers:** Trusted vendors who support hosting, payment, analytics, or communication services
- **Blockchain Network Participants:** For recording credential or transaction data on-chain, in a pseudonymous (non-personal) manner
- **Legal Authorities:** When required to comply with applicable laws or legal obligations

All third parties are required to handle your data securely and lawfully.

We retain your data for as long as your account is active or as required to:

- Fulfill our service commitments
- Resolve disputes
- Comply with legal obligations

Blockchain transaction data recorded on public ledgers may be permanent and cannot be altered or deleted.

We use advanced security measures to protect your data, including:

- Encrypted data transmission
- Secure storage practices
- Access controls and authentication layers
- Regular monitoring for vulnerabilities

However, please note that **no system is completely secure**, and blockchain transactions are publicly visible by design.
